Subject:	SOLAS Survey: Passenger Ship Safety Certificate
Reference:	SOLAS: CONARINA Procedures

SOLAS SURVEY: Passenger Ship Safety Certificate

Certificate Type: The certificate type is interim or short term.

Additionally, the type of voyages must be indicated. Choices are an international voyage or a short international voyage.

Country Name: The formal country name to be provided.

Name of Ship: It is to be obtained from the Certificate of Registration issued by the flag state.

Date Build: If a date for "Conversion" is entered, this is the date on which the contract is placed for the conversion, or in the absence of a contract, the date on which the work identifiable with the specific conversion begins.

Subdivisions

The information for these boxes is obtained from the vessel's load line certificate.

For ships constructed before 1 January 2009, the applicable subdivision notation "C.1, C.2 and C.3" should be used.

Items 2.2 to 2.9: Statements only: No Surveyor action is necessary.

Items 2.10 and 2.11: Cross out "was" or "was not" and "is" or "is not", as appropriate.

Item 3: Cross out "has" or "has not." Exemptions are granted by the vessel's flag administration.

Exemption Certificates are issued either by the Flag Administration or CONARINA.

Items 5 and 6: Cross out "was" or "was not" and "is" or "is not", as appropriate.

Validity date: SLP Certificates are issued valid for one year from date of survey. Place of issuance, date of issuance, and Surveyor's name are to be provided. Surveyor's signature is to be stamped.

Record of Equipment for SLP is similar to Form E and Form R, combined.

Particulars of ship: provide requested information accurately. Note that number of crew is not included in number of passengers the vessel is certified to carry.

Details of lifesaving appliances

-Provide number based on total number accommodated by lifeboats, life rafts, life jackets, immersion suits, and thermal protective aids.

-Total number of lifeboats and persons accommodated by them, on each side, always to be provided in this section.

- Read items and provide numbers only as appropriate. If the item is not applicable to the type of boat carried, do not answer the item. Mark "-" to items not applicable. For item 2.5, if the boats provided (e.g. open, oar) are not applicable to the categories previously indicated in items 2.2 to 2.4, indicate the number in 2.5.1 and the type in 2.5.2 (i.e., open oar).

For open type lifeboats, do not fill in any other lines in this section except items 2 and 2.1.

3 to 4.1 self-explanatory.

5 to 5.2.2 Note: items 5, 5.1, and 5.2 are titles, therefore, no lines for responses have been provided. The other items of this section shall be answered as applicable.

6 to 6.2 Buoyant apparatus are objects that float, other than lifeboats, life rafts, life buoys, or life jackets.

4.5.2.2 Details of radio facility

1 to 8 The instructions for Form R shall be referred to in order to complete these items.

4.5.2.3 Sections 4, 5, and 6

Again, these items are identical to those on Form R. Refer to instructions for completing Form R for these items.

Details of Navigational Systems and Equipment: This new section has been included in the record in accordance with Resolution MSC.99(73), which comes into force on 1 July 2002. Accordingly, all forms P (SLP records) issued prior to the SOLAS 2000 amendments coming into force date must be re-issued using the latest version of the form during the next SLP renewal survey on or after 1 July 2002. If the "function" of an item of equipment is incorporated into another piece of equipment, then it is to be noted on the Form P, for example; "(included in item 3.4 above)".

Place of issuance, date of issuance, and Surveyor's name to be provided. Surveyor's signature is to be stamped.
